**CLARK ATLANTA UNIVERSITY**, a leading research institution of higher education and one of the nation's most distinguished HBCUs, seeks a proven fundraiser to serve as the **Senior Director for Development and Major Gifts**. Reporting to the Vice President for Institutional Advancement, the Senior Director plays a key role in enabling the University to achieve its fundraising goals and objectives through relationship building and the securing of significant gifts.

## The Opportunity

Clark Atlanta University (CAU) is a comprehensive, private, urban, coeducational institution of higher education with a predominantly African-American heritage. Located in Atlanta, Ga., CAU offers undergraduate, graduate, and professional degrees, as well as certificate programs, to students of diverse racial, ethnic, and socioeconomic backgrounds. George T. French Jr., Ph.D. became the fifth President for Clark Atlanta University on Sept. 1, 2019.

The University produces graduates who have met standards of excellence in contemporary higher education, who are educated to be creative and to have a perspective on the world and its peoples. CAU graduates are leaders and innovators who are committed to leading *Lifted Lives of Success*.

CAU was formed with the consolidation of Atlanta University and Clark College, both of which hold unique places in the annals of African-American history. Atlanta University, established in 1865 by the American Missionary Association, was the nation's first institution to award graduate degrees to African-Americans. Clark College, established four years later in 1869, was the nation's first four-year liberal arts college to serve a primarily African-American student population. The main campus, which spans over 126 acres of land, is located about 1.5 miles southwest from the heart of downtown Atlanta.

Today, with nearly 4,000 students, CAU is the largest of the four institutions (CAU, Morehouse College, Spelman College, and Morehouse School of Medicine) that comprise

the Atlanta University Center Consortium. It is also the largest of the 37-member UNCF institutions.

CAU is classified by Carnegie as R2: Doctoral Universities – Higher Research Activity and is the only private, independent graduate research institution in the HBCU community, and the only HBCU member of the Georgia Research Alliance. The University is a United Methodist Church-affiliated university, approved by the University Senate General Board of Higher Education and Ministry of the United Methodist Church.

Forty major areas of study are offered across four schools – Arts and Sciences, Business Administration, Education, and Social Work. It awards Bachelor's, Master's, Specialist, and Doctoral degrees. There are 181 full-time faculty, of whom 92 percent hold terminal degrees and 65 percent have tenure status.

Retention of first-year students returning for a second year is 74 percent. CAU graduates are deeply employed in the growing economic sectors, such as business, film and media, medical and healthcare, and government.

Georgia students constitute 39 percent of the total enrollment, with 58 percent of the students from out-of-state, 3 percent from the Caribbean Islands, and 10 percent from more than 15 foreign countries. Female students constitute 75 percent of the total enrollment.

The University has more than 40,000 alumni fulfilling CAU's mission: *"Leveraging its distinctive history, Clark Atlanta University is an urban research university that transforms the lives of students and their communities by preparing citizen leaders to be problem-solvers through innovative learning programs; supportive interactions with faculty, staff, and students; exemplary scholarship; and purposeful service."*



### **George T. French Jr., Ph.D.**

*President of Clark Atlanta University*

CAU President George T. French, Jr. is a recognized leader in higher education. Among his many accomplishments, he is currently serving his third term on the Southern Association of Colleges and Schools Board of Trustees. He also is completing his second Congressional appointment to the National Advisory Committee on Institutional Quality and Integrity (NACIQI), serving two U.S. presidential appointments as advisor to the U.S. Secretary of Education.

Prior to his appointment at CAU, Dr. French served as President of Miles College from 2005-2019. Under his leadership, Miles College exceeded all fundraising goals in its history; achieved unprecedented financial composite score and credit rating scores; increased student access to educational funding; more than tripled the size of the existing campus with key land acquisitions; and elevated the total athletics program to the best men's program within the Southern Intercollegiate Athletics Association.

A native of Louisville, Ky., Dr. French earned a BA degree in Political Science with an emphasis in Policy Analysis from the University of Louisville. He was competitively accepted into the University of Richmond Law School and completed two years of studies before being recruited by Miles College to serve as the Director of Development. He completed his final year of law school at Miles Law School, earning a Juris Doctorate. Dr. French received his Ph.D. in Higher Education from Jackson State University and has completed Harvard University professional education programs for experienced college presidents.

## The Office of Institutional Advancement

The Office of Institutional Advancement has a leadership role in building and stewarding relationships in support of the academic mission, vision, and philanthropic goals of CAU. The Senior Director for Development and Major Gifts is an outstanding opportunity for a professional fundraiser to serve in a leadership role within a strong Advancement program. The Senior Director will work closely with the deans and faculty to achieve designated fundraising goals for the individual academic units as well as the overall University.

To accomplish goals, the Senior Director works collaboratively with internal and external constituencies, including faculty and volunteers, to devise and implement strategies for building relationships, predominately with individuals, designed to maximize philanthropic support for Clark Atlanta through major and planned gifts. A strong track record of effective identification, cultivation, solicitation, and stewardship, preferably in a higher education setting, of donors and prospective donors at the \$10,000 level or above is critical for success in this position.

The Senior Director will conduct personal visits with alumni and friends throughout the state and nationwide. A member of the Advancement leadership team, this officer is responsible for building and managing an assigned portfolio of donors and prospective donors. This includes participation in the identification of prospective donors, cultivation, solicitation, and stewardship activities.

### Additional Responsibilities

- Develop strategies for cultivation and stewardship activities.
- Maintain knowledge and understanding of best practices in higher education philanthropy and incorporate them into fundraising activities.
- Write or assist in drafting proposals and other materials.
- Assist with publicity arrangements on significant gifts.
- Attend and participate at University, Alumni, and other appropriate events, both on and off campus, to enhance the friend-raising efforts of the University.
- Identify, develop, and mentor the development team.

## Qualifications

A baccalaureate degree is **required**; an advanced or graduate degree is **preferred**.

Candidates must have a minimum of five years of successful experience as a development officer for an educational institution (preferred) or a non-profit organization, with demonstrated success in establishing and managing relationships with multiple donors. Must be thoroughly knowledgeable of planned gifts.

Outstanding communication and interpersonal skills and the ability to interact positively and professionally with both the community at-large and the internal campus community are required. Experience working with community and business leaders in business and social settings is essential for success. Must be able to travel and work evenings and weekends.

### Skills and Knowledge

- General knowledge of higher education required, and familiarity with issues of particular relevance to historically black colleges and universities - highly desired
- Knowledge of current tax laws, investments, and planned giving opportunities and the ability to use this knowledge in prospect cultivation and solicitation
- Computer literacy, including fundraising software, and strong presentation skills - essential
- Tangible experience of having expanded and cultivated existing donor relationships over time
- Ability to influence and engage a wide range of donors and build long-term relationships
- Ability to successfully construct, articulate, and implement annual strategic development plans
- Ability to work both independently without close oversight and as a team player
- Strong organizational and time management skills with strong attention to details
