The Position

PMHNP faculty members report to the Chair of the APRN/DNP program, with the Program Director overseeing all courses. To be successful in this position, a candidate must have experience in graduate-level instruction, scholarship, and clinical experience with PMHNP students and be active in clinical practice. Faculty will have opportunities to participate in departmental and university responsibilities.

Key Responsibilities:

- Collaborates with the PMHNP Lead Faculty, Practicum Coordinator, Advisor, Faculty Support Coordinator, and ultimately, the Chair of Doctoral Studies in Nursing to support the DNP/PMHNP program and PMHNP practicum courses and scholarly projects.
- Provides direct and indirect practicum supervision to designated students, consistent with the program and course learning objectives that includes advising, supervising, and evaluating PMHNP practicum students.
- Provides didactic teaching through Blackboard and Microsoft Teams.
- Provides direct support to PMHNP and Family Practice Practicum Lead Faculty through the grading of practicum assignments of designated students.
- Serves as the primary liaison on behalf of the School of Nursing between the Practicum Preceptor and Practicum Course Lead Faculty.
- Conducts evaluation of designated practicum students in the practicum setting at least once during each practicum course. This may include site visits or collaboration and dialog with student and preceptor via e-mail, electronic communications, or in-person. This evaluation will include the site, the preceptor, and the student's ability to meet practicum requirements and student learning objectives.
- Additional duties as assigned.

Minimum Qualifications


A graduate degree in nursing with preparation as a Psychiatric Mental Health Nurse Practitioner is required. A current and unencumbered Registered Nurse and Advanced Practice Registered Nurse license for the state where candidate is located if teaching online, or eligible for an unencumbered Registered Nurse and Advanced Practice Registered Nurse license in Virginia if teaching on the campus, is required.

Other requirements include:

- National certification as a PMHNP from the American Nurses Credentialing Center (ANCC) or the American Association of Nurse Practitioners® (AANP)
- Current certification in American Heart Association CPR for Healthcare Provider with an AED
- Excellent computer skills, including Blackboard and Microsoft Teams
- Current clinical practice in the role of PMHNP
- Excellent personal communication and professional manner

Preferred Qualifications

- DNP or PhD degree
- Certification as a FNP in addition to PMHNP certification
- Five years of experience as a PMHNP in a direct-care setting
- Experience in graduate-level instruction, scholarship, and clinical experience with PMHNP students
- Experience in practicum and student supervision
